Further to our letter ref: LTA/CR/C37.040.00/1363 dated 18 June 2012, we would like to update you on the above-mentioned project.



- **JUNCTION OF SERANGOON AVE 2 & 3**

<b>Blk 246 (Area 1):</b>	Completed drain & road widening works.
<b>Braddell Heights CC (Area 2):</b>	Replacement of existing gratings & reconstruction of road kerbs. Target completion date: by 3 <sup>rd</sup> quarter 2013.
<b>Blk 332 (Area 3):</b>	Reconstruction of 0.9m drain & road widening works in progress. Target completion date: by 3 <sup>rd</sup> quarter 2013.
<b>Blk 323 (Area 4):</b>	Construction of retaining wall & 1.6m drain. Target completion date: by 3 <sup>rd</sup> quarter 2013.
<b>Final Works:</b>	Milling & patching of the road junction. Target completion date: by 3 <sup>rd</sup> quarter 2013.

- **JUNCTION OF UPPER SERANGOON ROAD & AVE 2**

<b>Next to "Nex" Shopping Centre (Area 5):</b>	Construction of new 0.75m & 0.9m drains, RC sumps & box culvert in progress. Construction of new kerbs, road widening. Demolition of existing drains & kerbs. Target completion date: by 3 <sup>rd</sup> quarter 2013.
<b>Opposite Sunblade Condominium (Area 6):</b>	Demolition & construction of new kerbs. Installation of new vehicular impact guardrails. Target completion date: by 3 <sup>rd</sup> quarter 2013.
<b>Final Works:</b>	Milling & patching of the road junction. Target completion date by 3 <sup>rd</sup> quarter 2013.
